### **Bobcat Exhibit**

What adaptations do bobcats have?

Bobcats have very good hearing, smell and sight for locating prey. They have hair tufts on ear tips that act as antenna to catch faint sounds. Bobcats have retractable, sharp, sickle-shaped claws for griping. Bobcats have long, pointed canine teeth to kill prey.

## White-Tailed Deer

Spotted turtle populations are in decline due to loss of wetlands and the illegal capture and sale of turtles for the pet trade.

Lionfish are an invasive species. What does this mean and what is the impact?


<u>An invasive species are species that are introduced to the environment. They have few natural enemies to control their spread and decrease the populations of native species.</u>
